Annual Report for 2021

Mission Statement

The Ashtabula Municipal Court shall be effective and efficient when resolving disputes in order to uphold the laws and regulations of the court's jurisdiction and the State of Ohio. The Judge will interpret and apply the law with the utmost fairness and impartiality in order to protect the rights and liberties of all people guaranteed by the Constitution of the State of Ohio and of the United States of America.

The Annual Report for the Ashtabula Municipal Court (AMC) is to notify the public about the Court's programs, statistics and accomplishments.

AMC has one Judge, one Court Administrator/Clerk of Court, five part time Deputy Bailiffs / Security Guards who oversee the Courtroom; monitor the metal detector for the Justice Center along with serving Court documents to the public. The Court also has one part time Drug Court Administrator/ Deputy Bailiff.

AMC departmentalized creating the following:

Criminal/Traffic Department, Civil Department, Probation Department, Bookkeeping/Customer Service Department and Information Technology Department.

The Criminal/Traffic Department consists of one Supervisor Deputy Clerk/Judicial Assistant, one full time Traffic Clerk, and one full time Criminal Clerk.

The administration and staff have followed all protocol in regards to the Covid – 19 pandemic. AMC will continue to follow all protocol and/or procedures directed from the Ohio Supreme Court to ensure that the staff and public is safe.

BRIEF SUMMARY OF THE CRIMINAL/TRAFFIC DEPARTMENT

2021 continued to present many challenges due to the COVID-19 pandemic including staff shortages. Sanitation, protective gear, and public spacing measures were consistently provided and maintained to protect employees and the public. Adjustments were made as needed to address COVID-19 surges throughout the year. On a positive note, the Court was able to function in a normal capacity even though facing many obstacles.

The Court held a March Madness Clean Sweep program during the week of March 22nd -28th, 2021 on cases 2019 or older which allowed defendants to make a minimum payment of \$100 towards fines and costs which the Court doubled. The program included Probation fees as well. Total cash and credit cards receipted was \$44,875.05; total Clean Sweep credit was \$29,035.40.

Registration block and license forfeitures continue to be utilized to collect back fines and court costs. The LFF program is available to those who can't afford to pay the balance in full. Total traffic/criminal monies receipted for the entire year was \$811,722.30, which is an increase of 14.67% from 2020.

Total of new criminal and traffic cases filed: 6411. The case numbers greatly increased from the prior year; a total increase by 65.56%.

In summary, the Court sustains its mission to be effective and efficient by continuing hard work, dedication and flexibility in dealing with the obstacles faced by COVID-19.

A brief summary of the Civil Department from the Supervisor Deputy Clerk:

Civil Department consists of one full time Supervisor Civil Clerk, one full time Civil Clerk and one part time Civil Clerk.

The year 2021 continued to present obstacles due to the Covid-19 pandemic. Even though the CARES ACT/Moratorium ended in July 2020, new civil case filings totaled 877 versus last year's total filings of 881. Due to the lifting of the Moratorium, there was a 14% increase in Eviction filings. Wage Garnishment filings had a slight increase while Small Claims and Contract complaints declined by 19%. With the addition of our recent part-time hire, the backlog has been greatly reduced and we will continue to strive for our goal of zero backlog and efficient case processing.

Heading into 2022, the Civil Department is hopeful to accomplish our goals, increase productivity, and will adapt to any changes set forth by the Supreme Court.

Probation Department has three full time Probation Officers who can also act as Bailiffs.

A brief summary from the Probation Department:

In the year 2021, the Ashtabula Adult Probation Department received three hundred and seventy-seven (377) new cases to supervise. Fifty-four (54) cases were referred to the Pre-Trial Diversion Program, providing the eligible offender the opportunity to have the charge(s) dismissed after fulfilling court requirements. Sixteen (16) written Pre-Sentence Investigation reports were also completed by the Probation Department in 2021.

Per Ohio Revised Code 2951.021, the Court continues to require an offender placed under control and supervision of the Probation Department to pay a monthly supervision fee of \$25.00 and those offenders placed under non-reporting supervision to pay a monthly fee of \$20.00. In the year 2021, \$40,054.24 in Supervision fees and \$21,085.37 in Restitution was collected.

The Court also provides house arrest, ignition interlock devices and SCRAM (Secure Continuous Remote Alcohol Monitor) as tools for the Probation Department to supervise offenders. In 2021 ten (10) offenders were placed on a CAM device for a total of three hundred and seventeen (317) days. Defendants were monitored for an average of thirty-one (31) days. Ashtabula Municipal Court reached a 96.7% Sober Days rating, meaning of the three hundred and seventeen (317) days that defendants were monitored, 96.7% of them were quantifiably sober. The 2021 national average was 98.9%. In 2021 four (4) defendants served a total of one hundred thirteen (113) days on house arrest.

A sanction the Court continues to aggressively use for offenders is supervised community service work. Last year eighty-five (85) participants completed 2,335.50 hours in the Court's community service program. The offenders are required to work under the authority of non-profit and charitable organizations.

Ashtabula Municipal Court staff continues to be active with various professional organizations such as American Probation and Parole Association.

A brief summary from the Recovery Court Administrator:

Recovery Court held 2 graduations in 2021, graduating 5 participants. Treatment teams continues to meet weekly for Recovery Court to discuss participant's progress. We currently have 23 participants in different phases of the program. Frequency of court attendance is based on which phase the participant is currently in. The world continued to deal with the pandemic but we were able to continue to be in person putting safety precautions in place, utilizing social distancing and masks. The Advisory Committee meets every 4 months. Recovery Court received grants from the Department of Mental Health and Addiction Services in the amount of approximately \$55,000. We were able to use the money toward the salary of the Drug Court Administrator and for incentives for the participants.
