#### INFORMATION ON EXPUNGEMENT

### PLEASE READ BEFORE FILING AN EXPUNGEMENT

The attached form is used to request an expungement of a conviction and/or charge, which occurred in this Court. Once you file your expungement request, a background check will be conducted by the Court Probation Department. When the check is completed, the matter will be set for an oral hearing and the Court will notify you of the hearing date.

Please be advised of the following before you file your request:

- Attached to this packet is a list of charges, which are not expungeable by law. Please consult with an attorney before filing if you have been convicted or plead to one of these charges.
- That there are issues other than prior record, which may prevent the Court from granting an expungement. Again, please consult with an attorney if you have any questions regarding this issue.
- The fee to file the expungement is NON REFUNDABLE \$75.00.
- Even if the expungement is granted, please be aware some agencies or professions may have access to the information (i.e. Federal government, nursing, health care, teaching – this is not an exhaustive list). If you think this may be an issue, it is strongly suggested that you contact the state board which deals with your profession.
- Traffic cases cannot be expunged for ANY reason.
- The one year time period does not begin until any and all probation time has been completed and/or terminated.

# SB 337

- Redefines who is an eligible offender for purposes of sealing (expungement) of records.
  - Bill replaces "first offender" with "eligible offender"
    - "Eligible offender" is defined as a person who has been convicted of an offense in this state or any other jurisdiction and who has:
      - Not more than one felony conviction
      - Not more than two misdemeanor convictions, if the convictions are not of the same offense
      - Not more than one felony conviction and one misdemeanor conviction
